SCAVENGING PERMIT

The holder of this permit is allowed to scavenge from **October 1st to April 30th** at the following times and locations:

MONDAY 9:00 am – 11:00 am Brockton and Dingwells Mills Drop-Off Centers

THURSDAY 9:00 am – 11:00 am New London and Murray River Drop-Off Centers, and East Prince Waste Management Facility (EPWMF)

- 1. Scavenging copper, aluminum, brass, stainless steel or other non-ferrous metals (i.e., gold, nickel, silver, lead, zinc, etc.) from the metal pile, electronics or items at the household hazardous waste depot is prohibited.
- 2. Scavenging at landfill cells is prohibited.
- 3. Climbing metal, construction and demolition (C&D), wood piles, and concrete walls or perimeter fences is prohibited.
- 4. Entry to storage containers is prohibited.
- 5. Items containing ozone depleting substances (ODS), such as refrigerators, are not allowed to leave the premises until the ODS have been removed and/or items have been inspected by a certified technician and stamped ODS free.
- 6. No scavenging is permitted when any work is being carried out by IWMC staff or contractors at the metal, construction and demolition, or wood storage areas, including but not limited to baling or pushing up the metal.

7. No scavenging is permitted in the immediate vicinity of paying customers while they are offloading items.
8. IWMC reserves the right to inspect scavenged loads.
9. Scavenging is not allowed at any IWMC facility between May 1st and September 30th.
10. This permit must be presented to IWMC staff at the time of each entry to a Waste Watch Drop-off Centre or EPWMF.
11. IWMC reserves the right to discontinue scavenging at any time in its sole discretion.
12. This scavenging permit may be revoked should the permit holder fail to comply with permit conditions, posted site rules, or any direction of site staff.
13. Scavenging is at your own risk.
14. I, the permit holder referred to in this form, release and forever indemnify, discharge and save harmless IWMC, its directors, officers, employees, successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise, or may hereafter arise directly or indirectly, from scavenging activities at IWMC locations. I understand and acknowledge that this statement discharges IWMC, its directors, officers, employees, successors and assigns from any liability with respect to bodily injury, illness, death, property damage or any other loss that may result from my scavenging activities as contemplated by this permit.

I hereby acknowledge that I have read this application, and agree to comply with the conditions of the permit, and with all rules posted at IWMC sites.
